## Aim

The aim of the Academy is to establish a broad and complete foundation of knowledge of the Indian Laws and Rules governing the various aspects of Business and Commercial activity.

The Course will enable the students to expand their horizons and open up their mind academically and culturally to meet the challenges of today's globalizing world.

## Course Structure

GIBCLA course is a full-time, intensive programme, consisting of 45 contact hours over the three-week period, generally taking the form of 36 hours of lectures and 9 hours of tutorials. Due to the intensive nature of the course, students are expected to spend full day on campus. Lectures will be delivered by GNLU Faculty or by any other resource person who may be designated by the University to take lectures, each day for 5 working days a week. In addition to faculty led classes, students are recommended to spend 2-3 hours per day for self-study. Time table will be issued at the beginning of the Course. The expected hours of a particular paper will be informed to registered students in advance.

## Evaluation Scheme

Assessment for GIBCLA will be done through written examination and assignments.

## Certification

All students will be provided with a certificate that will include their name, course and grade.

## Eligibility

Summer School is open for students pursuing graduate and post graduate studies in law, member of academics and professionals of allied disciplines.

The Academy reserves the right not to organize the course in case the number of responses is less than the minimum intake. It is further made clear that the fee received will be returned with necessary deduction.
