The IndusAcX Summit 2025: The Industry–Academia Exchange aims to create a vibrant platform for academic interaction, interdisciplinary dialogue, and collaborative research. The Summit represents a unique initiative that brings together academicians, industry experts, and policymakers on a common platform to discuss the growth and development of niche and emerging areas of law and policy.

The Summit seeks to promote a strong research culture and foster meaningful partnerships between academia and industry. It invites extended abstracts (500–600 words) addressing innovative legal, policy, and regulatory challenges in the thematic areas of ESG, Carbon Markets and Sustainability; AI, Data Protection and Technology Law; Construction Law, Contracts and Arbitration; and Aviation Law.

Selected participants will present their papers and engage in interactive discussions with scholars, practitioners, and industry leaders during the Summit, contributing to a dynamic exchange of ideas that will shape the future of law, policy, and industry collaboration.

Faculty members who are employed full-time at any recognized law school in India and Abroad.

Conference Participation and Evaluation Process



Stage 1: Extended Abstract Submission

- Participants must submit an Extended Abstract of 500–1000 words.
- Abstracts will be evaluated based on originality, relevance, and clarity.
- Selection: Up to 7 papers per thematic vertical will be shortlisted for the next stage.
- Important Note: Abstracts containing plagiarized or Al-generated content will be summarily rejected.
- Deadline for Submission: 20 November 2025
- Selection Communication: 23 November 2025
- The subject line of the email should clearly mention the name of the relevant vertical (e.g., "Abstract – Construction Law, Contracts, and Arbitration") to email id: indusacx_sol@dau.ac.in

Stage 2: Draft Paper Submission

- Selected participants must submit a Draft Paper of 500-600 words by 5 December 2025.
- All Draft Papers will be shared within the respective vertical for peer review, comments, and feedback.
- The organizers will also provide guidance to enhance the quality and policy relevance of the research.
- This exercise will help participants refine their work for potential publication in reputed journals indexed in Scopus, Web of Science, or ABDC.
- The organizers, however, will not be responsible for publication support.

Stage 3: Peer Review and Pre-Conference Preparation

- Each selected participant is expected to read and review the Draft Papers of their fellow presenters within the same vertical.
- Draft Papers will be circulated one week before the conference
- Participants should come prepared with constructive comments, insights, and suggestions to enrich the discussion during the conference.
- Peer evaluation will complement expert review in determining the Best Paper Award.

Stage 4: Conference Presentation and Discussion

- Each presenter will have 30 minutes total:
 - 1.15 minutes for presentation
 - 2.15 minutes for Q&A and expert feedback
- Presentations must be made using a PowerPoint (PPT) of up to 7 slides, covering the following points:
 - Title and Author Details
 - Problem Area / Background
 - · Research Questions and Objectives
 - Methodology (if applicable)
 - Key Findings / Arguments
 - Policy Implications / Suggestions
 - Conclusion



Awards and Benefits

- **Best Paper Award:** ₹11,000 (per vertical)
- ► Travel Reimbursement: Up to ₹15,000 upon submission of valid receipts (per paper)
- For International Participants: Reimbursement up to ₹30,000 upon submission of receipts (In exceptional circumstances, online presentations may be permitted)
